I have been blessed with a career path filled with professional opportunities and growth. Trained broadly as a sociologist with health interests, I later earned my MBA, expanding my administrative skills. While working in a university research center, I was asked to direct the Center for Idaho Center for Disabilities Evaluation and so acquired direct experience in health care management. Concurrently, as a faculty member teaching health care management, I rose from an assistant professor to department chair at Idaho State University before moving to East Carolina University where I served again as a program director in Health Services Management and was subsequently promoted to full professor.

I am grateful for having received recognition for my teaching by peers and the university system and especially students. In addition to publishing three textbooks, two in second edition (*Ethics and Professionalism for Healthcare Managers*, *Essentials of Healthcare Management: Cases, Concepts, and Skills*, and *Healthcare Marketing: A Case Study Approach*), I have published over 45 book chapters and peer reviewed articles. My professional activities include years of service on the executive committee (Past Chair) of the Association of University Programs in Health Administration (AUPHA) and editorship for the *Journal of Case Studies*.
